David "Prophet" Ambrose, Foley, MO, served USMC, Vietnam 11/67-10/69, 3rd Force Recon, 3rd Marine Division, Current Missouri President of In Country Vets Motorcycle Club, Has been with the Run since 1988, Has worked to support it each of those years, Generally runs from Wentzville to DC.

## From The Chairman Of The Board

It was demonstrated by their acceptance of the positions when asked to serve. It was further demonstrated by their willingness to travel to this critical meeting at their own expense. Each member discussed their resolve to guide and support the RFTW. The immediate needs of the non-profit organization had to be addressed. We set out to bring the non-profit organization back into good standing with the State of Illinois. This was done with our election of officers, filing of appropriate papers and the ratification of by-laws. These responsibilities had been neglected and required a significant portion of our two day session. The completion of these duties and responsibilities meant that the meeting could only involve members of the Board.

The members of the board are myself, Ron Eschinger, Chuck Parola, Lynda Papaioanu, Joe Lozano, Suzanne Sigona, George Cheney, and David Ambrose. You will read more about them in this copy of the newsletter. As we examined our individual concerns regarding the Run and the purpose, we were speaking in one voice regarding the "healing" that is offered by this experience. As we set out to do our work, we concentrated on the concerns that had been raised by participants and focused on what could be accomplished to address many of those concerns. The Board also wanted to be sure that this Run is operated with consideration of more than one or two people. Information regarding many of those adjustments can be reviewed in Deekin's column.

As we gather in Ontario, California in May, 1999 to begin our trip across the country let us gather in the night before to begin our own healing. This will allow us to depart on Wednesday morning with the focus of Riding for Those Who Can't. Let us all have a splendid ride and continue to build our RFTW family so that we can remain dedicated to our cause. Again, I want to thank everyone who has helped in any way possible to insure that RFTW remains a healthy organization in POW/MIA awareness. As we cross the

continent, may we remain united.

## View From the Front, ... 1999 edition

Imagine my surprise when opening my e-mail one chilly, snow-bound morning in January to find that Terry Porter was appointing me as national coordinator for the run effective immediately. Quite a shock, given the fact that I had volunteered to lead the run in 2000 and wasn't planning on doing anything really challenging in 1999. The newly installed board of directors confirmed Terry's appointment a few days later and things have been progressing ever since.

Many of you have likely noticed that the run is growing each year. This continuing growth requires the run become more organized to continue its purpose of providing the participants with a safe and secure journey to Washington D.C. One result of the re-organization was the expansion of the board of directors. The expanded board is comprised of individuals that have been involved not only with Run For The Wall in past years, but they also have experience with POW-MIA issues and veterans issues. I have ridden with all of them in the past and have spoken with all of them at length before accepting this job. I am convinced that each and every member of the board is well-qualified for their position and I look forward to working closely with them to continue

#### improving the run.

One of the areas the board has sought to improve is rider safety. The board presented me with a mandate regarding the run; get everyone from California to Washington in a safe and secure manner. Safety is paramount. This included getting the run off the road as early as practical each day to give everyone a chance to visit with each other and to rest. The board also wanted the run to spend more quality time at the Navaho Reservation in Window Rock, Arizona. To reach these objectives, some changes had to be made in this years route. The first major change is the starting date and location. The run will depart from the TA Truckstop in Ontario, California, on May 19, 1999 at 8:00 a.m. The change of the starting point was made for many reasons. Starting at the Queen Mary in Long Beach was truly an impressive kick-off for the run, but the majority of riders felt the challenging traffic conditions and extra time spent navigating the challenges were too high a price to pay for the memorable send off. The first overnight stop will be in Ash Fork, Arizona. Additionally, because the board set time at Window Rock as a high priority, the distance between California and Gallup has to be done in the most efficient way possible. That means starting in Ontario. After deciding to start in Ontario, changing the starting date became obvious. The earlier departure date was to accommodate leaving from Long Beach. Leaving from Ontario achieves two separate objectives: continuing the ten day tradition of the run, and reduces the challenges weathered in the transit out of Long Beach.

After departing from Ash Fork, we'll do a relatively short (233 miles) ride to Gallup, New Mexico. We will make camp in Gallup and then backtrack to Window Rock in formation to visit with the Navajo Nation. Participants may stay in Window Rock as long as they please before returning to Gallup. It is anticipated that people will return to Gallup individually or in small groups, much like the trip from Hugo back to Limon. Then we'll leave Gallup and head to Cimarron, New Mexico. Keeping the priority of getting into camp as early as practical, we will not be stopping at Angel Fire Memorial that day. Rather, we'll be leaving Cimarron at 7:30 a.m. the following morning and riding to Angel Fire for quiet reflection and perhaps breakfast before heading on to Pinon and then on to Limon for the night.

The reason for these changes is due to the growth of the run. We have 10 days to get from California to Washington. The distance between those two points remains constant: approximately 2700 miles. A larger pack requires more time, gas and meal stops take longer, eroding time spent on the road. Some other stops that do not include either gas or meals are simply no longer a possible. If the media wishes to cover this event, we will make arrangements to meet them at a gas or meal stop. Few other changes are expected before we reach Washington. The stop at the lwo Jima is restored. It is necessary to stop at the lwo for several reasons: to pay our respects to out Navy and Marine Corps brothers, (yes, one of the men on the lwo is a sailor, an FMF corpsman); to give everyone the chance to briefly rest from the ride into Washington; to give folks a chance to prepare themselves for the Vietnam Veterans Memorial Wall; and to meet out police escort - so critical in getting us to The Wall through Washington's rush hour traffic safely. Other changes in Washington include a new hotel. We will be staying in Alexandria, Virginia instead of Fairfax, Virginia. (See the enclosed revised schedule for complete information.) This change also requires a relocation of our Friday night dinner from the Black Eyed Pea. Efforts will be made after this run to stay and eat where we have in past years. In any event, some folks will be going over to the Pea and T.T. Reynolds to let them know that they are still our friends and that we have not forgotten them. I'm looking forward to serving you and providing you a safe, efficient run. I'm hoping that you look to do the same. ## **First Board Meeting**

On January 9, 1999 the Board embarked on a two day session to realign the framework of the Run for the Wall. Each member seemed to silently recognize the responsibility they each shouldered. As we gathered in Colorado Spring, the greetings were something like, "Oh you're 'that' guy. and "I DO know you!"

The meeting got underway with a full program relating to the by-laws and corporate structure. A resolution was passed to adopt and ratify the actions of the State Coordinators and members that was taken during a special meeting on December 20, 1998. This meeting established the current Board of Directors. Resolutions were adopted regarding the structure of the corporation, the composition of the board, the term of service for board members, the process of succession and the number of meetings per year.

There was a motion made and passed that on January 9, 1999 that we would accept the unsolicited resignation of Terry Porter. Further, the Board honored Terry's request to have the resignation retroactive to 12/24/98. The Board also accepted Terry Porter's recommendation that Dan "Deekin" Coyne be the replacement for the current position described as "national coordinator".

A significant amount of time was devoted to assessing the preferences of the participants (as expressed through the survey summaries) and the basic needs of riders. The reported survey tally indicated that people set our Window Rock visit as a priority. The other information to be factored was the interest in not leaving from Long Beach and the interest in avoiding the additional day. Consideration was also given to safety, those who value the time to share their experiences at the end of the day, and the campers (who might like to set up their tents in daylight). With priorities set and a skeleton of a route, the final schedule was left for the Chairman and Deekin to work out.

In terms of merchandise related to the Run, a determination was made that items using the Run for the Wall name must be reviewed by the board. This is in line with the legal acquisition of the rights related to the Run For the Wall name. Other topics discussed included - a policy on vendors - merchandise sales - financial support - the newsletter - the web site - the "End of the Run" dinner (see information from Ron Eschinger).

Committee were established with board members - please make note of these if you have questions regarding any of these matters.

A motion was also made and passed to contribute the proceeds of two of our 50/50 drawings to support the repair of the North Wall. An article with updates on this situation should appear in our next newsletter.

For those who don't know, the costs related to the preparation and mailing is currently about \$1000.00. We want to see what transmissions can be done electronically and also want to see who wants to stay on the list.
