- 3. To participate in Rolling Thunder in support of their demand for government accountability for POW/MIA's.

FREQUENTLY ASKED QUESTIONS (FAQ's)

Q: What should I expect on this ride?

A: Expect to experience a unique opportunity to share your experiences with others and in the experiences of others.

Q: How much money should this trip cost?

A: A minimum of \$100 per day for people staying in hotels and \$50 per day for those that camp.

Q: Is it true that many meals and campsites are provided free?

A: There are some campgrounds that do provide free camping and several of our stops will provide some meals. It should be noted however, that all participants should expect these instances as the exception and not the rule. Everyone should be prepared to personally fund their own way across country and their return home.

Q: What type of clothes should I take?

A: Be prepared for 100 degree temperatures going across the desert, possible snow going through the Rocky Mountains, rain, hail, sun and, as in the case of the 1999 run, absolutely great, clear and cool weather all across

country.

The History of the POW-MIA Flag

In 1971 Mrs. Michael Hoff, an MIA wife, recognized the need for a symbol representing our Prisoners of War and Missing in Action. Mrs. Hoff contacted Norman Rivkees, Vice-President of the Annin & Company, which had just made a banner for the newest member of the United Nations as a part of their policy to provide flags to all UN Member Nations. Mrs. Hoff found Mr. Rivkees very sympathetic to the POW-MIA issue. He, along with Annin's advertising agency, designed a flag to represent our captive and missing. The simple message of the symbols on the flag is very eloquent. The stark white on black, the letters "POW-MIA", the guard tower, the armed guard, the barbed wire, the one lone serviceman with head down waiting, and the words "You Are Not Forgotten", all serve to create an unmistakable image and prompt all who see it to remember. Since its inception this flag, which was designed on behalf of American POW-MIA's from the Vietnam War, has come to represent our missing countrymen and women from all wars. The POW-MIA flag has been ruled legally to be "public domain"... as is the American Flag. It can not be claimed as the sole property of any organization or individual. The POW-MIA Flag flew over the White House for the first time on National POW-MIA Recognition Day 1988. On March 9, 1989 it was installed in the United States Capitol Rotunda. This occurred as a result of legislation passed overwhelmingly during the 100th Congress. Additionally, in a rare demonstration of bipartisan congressional support, the leadership of both Houses hosted the installation ceremony. With the joint Resolution of Congress, the POW-MIA Flag (the only flag ever displayed in the Capitol Rotunda) stands as a powerful symbol of national commitment to American Prisoners of War and Missing in Action.

On August 10, 1990 the 101st Congress passed U.S. Public Law 101-355 which recognized the POW-MIA Flag and

designated it "as the symbol of our Nation's concern and commitment to resolving as fully as possible the fates of Americans still prisoner, missing and unaccounted for in Southeast Asia, thus ending the uncertainty for their families and the Nation."

The POW-MIA Flag's importance lies in the continued visibility of this symbol as a constant reminder of the plight of America's POW-MIAs. Other than "Old Glory", the POW-MIA Flag is the only flag to fly over the White House and has flown in this place of honor on every National POW-MIA Recognition Day since 1988. The POW-MIA Flag flies on Veterans Day and Memorial Day at the National Vietnam Veterans' Memorial (The Wall), on Federal buildings, State buildings, at each National Cemetery, and at military installations worldwide. It also flies at countless additional locations throughout the nation every day of the year. Those Americans and organizations that fly the POW-MIA Flag do so to demonstrate their loyalty and sincere dedication to all Prisoners of War and Missing in Action and to their return ...both alive and dead. Deekin - you did a great job this year. Board Members - your hearts are in the right place, nothing is perfect at least as perceived by some others. State and Area Coordinators - outstanding job - ALL OF YOU - it just gets better every year. To Everyone Who Helped in ANY WAY - I "Thank You" for myself and I know that everyone remembers "WE RIDE IN FREEDOM FOR THOSE WHO CAN"T"

I will always remember me telling him "THIS IS YOUR WELCOME HOME THAT YOU NEVER GOT" Trying to clear my eyes of the tears that were flowing from them Which is not easy to do two up on a gold wing going 5 miles an hour. I hope now that he uses my invitation to bond with his brother hood every year. The Second, My SON (Crumbs) rode across America and got an education concerning the cause. He talked to the vets and formed his opinions about the wrong that is being done to the POW's and MIA's and to the vets that served and etc. etc. He vowed to carry on and inform his generation and his future generations of these injustices. So again I have contributed to the cause. When I got to Ontario, CA I found a couple of people that were FNG'S. They became my friends; they became my responsibility on the run. I was responsible for them feeling part of the family, which was my self, proclaimed commitment to the cause. In closing I say work on the cause and all the other stuff will take care of itself. Friendly Fire

Need to find a Gunship Crew** In South Vietnam on May 8th 1968 I was with B Co. 4th Btn 12th Inf. 199th Light Infantry Brigade on the outskirts Southwest of Saigon in a village called Binh Tri Dong. Our company had been ordered to proceed to a new firebase set up to the north of the village and to sweep through the village on the way. An NVA Battalion sized force had dug itself into the village and when our company approached the village, the dug in battalion opened their ambush. During the firefight that lasted that day more than 8 hours, we called in helicopter gunship support. A Huey Gunship flying parallel to a ditch where most of our company had deployed fired both of his 2.75 rocket pods. The left pod rockets hit NVA positions just 25-50 feet from the ditch while some of the right pods rockets went wide impacting in the ditch. I was an RTO for the CP group and had given the CO and Artillery Laison Officer my radio and joined my squad about 20 feet from the CP area. One 2.75 rocket from the gunship that fired wide impacted between me and the CP wounding myself, the Commanding Officer and the Artillery Laison Officer. I have contacted the medic that treated me in the field that day and he was told I arrived DOA at 93rd Evac. in Long Binh. I need the gunship crew to know that I WAS NOT killed, if they tried to check on me they probably got the same story. They shouldn't have to live with that trip this long.

I got involved in '91 and there are those who check this site who have more years than me. The computer has people looking for so much more information at a faster pace. We leave on a Wednesday - It's a 10 day ride. We ride for the POW/MIA issue and we participate in Rolling Thunder. In terms of "what's new" - I think that each of us own that and folks are doing a good job. Dragon let you know that he was going to organize a gathering in Ignatio. Mountainman said he was opening his home to people who want to gather in October. We've been able to keep up with the well being of some of our family. The POW/MIA balloon was launched in California this week. POW/MIA recognition day is September 17. The post office just released a new stamp "honoring those who served". In earlier years, the notice was all anyone ever had. It generally came out some time after the first of the year. When Linda and John handledthe Run - Linda decided to take a stab at a newsletter. She would beg for articles but was generally left to put together the scoop from her contact with folks. She gave us a new vehicle for communication. The newsletter rarely came out before the October reunion. Usually everyone went into their busy lives over the holidays and about the second week in January we all get antsy and start calling each other. We all leave each other in May with the intentions of putting out a newsletter right away and whatever...... Many folks find that they have put so much aside to make this trip that it takes quite a while to get their world focused back in this direction. I've seen a couple of postings by board members, saying something to the effect - - - If you have questions, contact me. - - - If there is something you are needing to get from them, give them a call. I don't imagine there are "secrets". The postings belong to each of us. Most everyone I know who works with the run and this issue is usually a person who is working on about 10 other projects. You know the old saying, that goes something like "if you want something done give it to the busiest person." All this to say, you may feel out of the loop on information because the computer gives us quick access. Typically, there just isn't much to "report".

The Qualities of Survival

Several years ago I found myself a long way from home in a small prison cell. As a prisoner of war, I was tortured, humiliated, starved and left to languish in squalor for six years. It's important that you get a vivid mental picture of this scene. Try your best to smell the stench in the bucket I called my toilet and taste the salt in the corners of my mouth from my sweat, my tears and my blood. Feel the baking tropical heat in a tin-roofed prison cell - not that you'll ever be a POW. If I am effective in these few moments we spend together, you'll see that the same kind of challenges you face as a teenager, a student, a leader, or a parent, are the same basic challenges I faced in a prison cell: feelings of fear, loneliness, failure and a breakdown of communication. More importantly, your response to those challenges will be the same response I had to have in the prison camp just to survive. What qualities do you have within you that would allow you to survive in a prison camp? Please pause here, think about this question, and write in the margin of this page at least five different qualities necessary for survival. (If you've written faith, commitment or dedication, you've already broken the code.)

As I worked my way through the first several months and then years of imprisonment, I found I already had a foundation of survival tools learned in life from my parents, preachers, youth leaders, and teachers. And the life-saving techniques I used in that prison camp had more to do with my value system, integrity and religious faith than anything I had learned from a textbook. Sound like your life? The adversities you face in your life can be just as debilitating to you as six years in a Communist prison camp could have been to me. Now here's the test: The next time you have a huge problem facing you, turn back to this page and read not my writing but your writing in the margin. You'll find that the same factors you've written here, which would serve you well in a prison camp, will serve you even better in the challenge of everyday life.

NEWS RELEASE RFTW SOUTHERN ROUTE

The Board of Directors for Run For The Wall has empowered a Southern Run Committee (SRC) to establish a route from Ontario, California to Washington DC. This committee consists of Phil Wright (Chairman), Ray Michalowski, Dave Erickson, Jim Doimas and Tom Titus.

There will be a "Shakedown Run" in May 2000 to determine that the scheduled route will work well for a full SOUTHERN RUN FOR THE WALL (SRFTW) in 2001. The "Shakedown Run" will be done by a MAXIMUM OF 20 BIKES leaving Ontario, CA on 17 May 2000, at the same time as the Central RFTW run. This will be a NO FRILLS, BARE BONE, PAY YOUR OWN WAY, NO ATTITUDES RUN.

If you are interested in being part of the Shakedown Run you must have experience riding in a group, have gone ALL THE MAY (CA to DC) at least once, single riders or two up, and understand that we will be moteling it all the way this first year. NO OFFENSE INTENDED, WE LOVE YOU ALL; however, we feel it necessary to limit this first year to bikes only (no sidecars, trailers or three wheelers) for the sake of flexibility and planning. WE NEED TO HEAR FROM THOSE INTERESTED NO LATER THAN 31 December 1999. Provide your name, Address, phone and E-mail addresse to the Chairman of the SRC below.

We will need the help of State Coordinators, or persons willing to help coordinate for your state, from Texas, Louisiana, Mississippi, Alabama, Georgia, North and South Carolina, and Tennessee and volunteers to check road conditions on the route and help plan gas, meals and night stops. WE NEED TO HEAR FROM YOU BY 15 NOVENBER 1999. Anyone in these areas having

suggestions for social stops (VAMCs, memorials, etc.), please contact the SRC.
